- 2. foster and develop operations research education;
- 3. increase the role of operations research both its main role and its role as a support for other sciences in order to contribute to improving human resources for the success of the nation and state development based on Pancasila (the state ideology) and the 1945 Constitution.

In order to achieve the above objectives, we as Indonesian operations research specialists, users and enthusiasts establish an association with the following Articles of Association and Bylaws.

CHAPTER I: NAME, DOMICILE, AND DURATION

Article 1 Name

Article 2 Domicile

- 2. The IORA Secretariat is in accordance with the domicile of the chair, with the jurisdiction covering the territory of the Republic of Indonesia.

Article 3 Duration

- 2. Publishing reading materials, periodic media and other means of communication to channel works and news in the field of operations research as information and knowledge for members and the public in general.
- 3. Improving members' abilities through education and training.
- 4. Popularizing operations research in order to support Indonesia's national development.
- 5. Establishing cooperative relations in various fields with other similar organizations, both at home and abroad.
- 6. Seeking non-binding donations from various sources to assist the organization's activities in the context of developing operations research that do not contradict applicable regulations.
- 7. Carrying out other activities that are not contrary to the prevailing laws and regulations.

CHAPTER III ORGANIZATIONAL STRUCTURE

Article 7 Membership

- 1. IORA membership consists of:
 - a. Ordinary members
 - b. Extraordinary members
 - c. Honorary members
- 2. Membership as mentioned in paragraph (1) above is regulated in the Bylaws.

Article 8 Board of Management

- 1. The IORA Board of Management consists of:
 - a. Central Board of Management
 - b. Regional Board of Management
- 2. The composition of the Central Board of Management is as follows:
 - a. one chair
 - b. at least one deputy chair
 - c. at least one secretary
 - d. at least one treasurer
 - e. division coordinators
- 3. The divisions referred to in paragraph (2e) shall cover at least:
 - a. Division of research and development
 - b. Division of education and training
 - c. Division of publications, documentation, and public relations
 - d. Division of industry and environment
- 4. The composition of the Regional Board of Management is in line with the composition of the Central Board of Management with the necessary adjustments, by taking into account the local interests.
- 5. The IORA management service period for each member's term is 3 years. The authority, duties and obligations of the Central Board of Management and the Regional Board of Management are regulated in the Bylaws.

Article 9 Organizational Powers

- 1. The Organizational Congress holds the highest authority in IORA
- 2. The Organizational Congress is held at least once in three years
- 3. The Organizational Congress is open to all members
- 4. The Congress establishes the general policy of the organization
- 5. The Congress adopts or amends the Articles of Association and Bylaws
- 6. The Congress elects and approves the Central Board of Management of the Organization
- 7. The procedure for holding a Congress is regulated in the Bylaws.

Article 10 Central Board of Management Meeting

- 1. Periodic meetings of the central board of management shall be held at least once a year.
- 2. A working meeting between the central board of management and the regional board of management shall be held at least once during the working period of the board of management no later than 6 months before the Congress.
- 3. All meeting resolutions should be adopted by deliberations to reach a consensus, and in the event deliberations to reach a consensus fail, resolutions shall be adopted by means of voting.
- 4. The procedures for adopting meeting resolutions as referred to in paragraphs (1) and (2) are regulated in the Bylaws.

CHAPTER IV CLOSING PROVISION

Matters that are not yet regulated in these Articles of Association shall be resolved at the Association's Congress.
